Course** of one-year duration with an annual intake of 100 students from the academic session 2009-2010 vide Order No F.NRC/NCTE/F-7/UP-3254/145 Meeting/2009/7817-7824 dated 12.08.2009 and revised recognition order was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16 vide order no. NRC/NCTE/NRCAPP-3254/2015/144341-46 dated 10.03.2016.

The matter was placed before NRC in its 397<sup>th</sup> (Blended mode) Meeting held on 18<sup>th</sup> & 19<sup>th</sup> April 2023 and the Committee decided to constitute VT. The VT was constituted on 08.06.2023.

3. **And Whereas**, the VTR was placed before NRC in its 401<sup>st</sup> Meeting (Blended mode) Meeting held on 27<sup>th</sup> June, 2023 the Committee decided as under:-


